Why should I give? Jesus gave his disciples two instructions which helpfully summarise our responsibilities as Christians. The Great Commandment says, "Love the Lord your God with all your heart and with all your soul and with all your mind" and "Love your neighbour as yourself" (Matt. 22:37-38). The Great Commission says, "Go and make disciples of all nations" (Matt. 28:19).

If we take these commands seriously then we'll do everything we can to love God, love others, and to help people to know Jesus as their personal Saviour, Lord & King. This will include ensuring St Paul's is properly resourced.

The final decision as to how much we give is a personal one and you are under no pressure from us. We understand that not everyone will be able to make a change. But the Bible does provide guidance on the matter. In the New Testament (especially 1 & 2 Corinthians) we see the following principles concerning our giving: *It should be regular, not just when we feel like it. *It should be budgeted. *It should be a realistic proportion of our resources. *It should be cheerful & not reluctant. *It should be generous and sacrificial.

- Read what the Bible says about giving & reflect on what God is saying to you
- Pray about your giving, asking God to guide you in your decisions
- Respond with love & overflowing generosity in resourcing the mission of St. Paul's Church here in Canford Heath & beyond.
